

Privacy Policy regarding use of website and project database

This privacy policy describes how DAW collects and uses the personal information that you leave and / or provide when you visit our website and use the various services and features that we offer on the website.

1. Collection of personal data

We will always inform you before collecting your personal information. For example, we collect the following personal information about you: name, birth year, nationality, pictures.

Note that certain personal information is required that we collect in order to use the website's features. The relevant forms will indicate whether the disclosure of personal data is mandatory or optional. If the disclosure of personal data is obligatory, that field will be marked with an asteric(*). If you choose not to provide the relevant personal information, you may not be able to use the desired function. For example, we need your contact information to answer a request from you.

If you provide personal information about others than yourself, we encourage you to obtain the consent of these persons first to provide the information.

2. Use of personal data, purposes and treatment basis

We collect and use personal information in connection with the features and purposes described below. We may also process your personal information for other purposes if we are entitled or legally obliged to do so.

We use personal information in the form of name, birth year, nationality and pictures. The purpose is to expand our database on the website with descriptions of the artistic projects performed on the SVK and with the necessary personal data relating to the persons who have access to SVK to carry out the project. We collect and use personal data based on the Personal Data Regulation GDPR art. 6 (1) (a) and (b).

The information is freely available, but is not disclosed by the SVK to third parties.

Cookies

We use cookies on our website. You can read more about our use of cookies in our Cookie policy, which you can find here: https://svfk.dk/om

The processing of personal data we collect through cookies is based on your consistency. You can read more about the terms of consent in section 3 below.

At www.svfk.dk we use cookies to investigate how our website is used. The informations that appear in our statistics are anonymous and cannot be traced to any individual.

3. Consent

When using our website, we collect and process your personal information in accordance with your consent, cf. section 2 above.

Please be aware that you can withdraw your consent at any time. This can be done by contacting us (see contact information in section 8 below).

If you withdraw your consent, we will stop processing your personal information unless we are legitimate or required to continue processing or storing your personal information on any other basis, including under the laws.

Withdrawal of your consent does not affect the legality of the treatment that has taken place before the withdrawal of consent.

If you withdraw your consent, you may not be able to fully utilize the features that we offer on our website.

4. Safety

We have implemented appropriate technical and organizational security measures to ensure a sufficient level of security. Thus we do our best to ensure the quality and integrity of your personal information.

5. Your rights

You are entitled to gain insight into the personal data we treat about you, with certain exceptions required by law.

In addition, you can object to collection and further processing of your personal information. Additionally, you have the right to correct your personal information or ask us to restrict the processing of your personal information.

If you ask for it, we will delete the personal information we have recorded about you without undue delay unless we can continue the treatment on another basis, for example, if processing is required to determine a legal requirement or if necessary for to answer a request from you.

If you wish to make use of your rights as described above, feel free to contact us (see contact information in section 8 below).

In connection with inquiries regarding your rights, we ask you to provide us with sufficient information that we can process your inquiry, including your full name and email address, so we can identify and respond to your request. We will respond to your request as soon as possible and no later than one month.
